2010-2011 TUITION ASSISTANCE (SCHOLARSHIP) APPLICATION

Tuition for the 2010-2011 Leadership Brevard Program is \$2,500 per participant, and includes meals, transportation during seminars and materials for all sessions. It is expected that employers and family of all participants understand and support the significant commitment of time and funds that participation in Leadership Brevard requires. Leadership Brevard is committed to including qualified applicants regardless of financial ability; however, participants are expected to contribute whatever portion of tuition their finances will permit.

A competitive program of tuition assistance is available for individuals who are not able to finance their participation from their employers' or personal resources. Tuition assistance is in the form of grants from the Leadership Brevard Alumni Scholarship Fund. Requests for assistance will be considered on the basis of demonstrated need and class composition.
